SUBJECT: Sports Center Door Upgrade

REQUEST

The Committee is to provide direction to staff on whether or not to proceed with upgrading the access point of the fitness floor from the 2^{nd} floor stairwell.

HISTORY/BACKGROUND

Staff received a request from Councilor Black based on concerns that were presented to him from Sports Center members to review the point of access of the fitness floor from the walking track. The concern is that members whose membership levels only authorize access to the walking track are using the stairwell on the 2nd floor to come down to the fitness floor.

ANALYSIS

Staff solicited quotes for install an access door or a gate at the 2nd floor stairwell that requires members to scan their membership cards to access the fitness floor. The installation of either a full door or a half gate at the top of the back stairwell will provide the following:

- This door will be used as an access point to allow members with a full membership onto the fitness floor
- It will be a stopping point for walkers who only pay \$25 a year access to the equipment on the first floor
- It will be a stopping point for walker plus memberships who only have access to the walking track and group fitness classes
- It can address safety concerns
 - o Members who have access to the fitness floor are given the opportunity to meet with a personal trainer and shown how to properly use all the equipment
 - o Walkers and Walker plus memberships do not get this with their memberships

FISCAL IMPACT


Based on the attached proposal, the total cost for installing the door is \$8,430. The total cost for installing the gate is \$6,300. Should Council proceed with this request, the funding source would be the Capital Projects Fund.

RECOMMENDATION

Staff is requesting Council direction as this is a Council initiated request.

SUBJECT: City Center Shelter Price

REQUEST

Council direction is requested regarding the price for the rental of the shelter at City Center.

HISTORY/BACKGROUND

Per its current policy, the City charges \$50 per three-hour block for rental of the park shelters.

ANALYSIS or STAFF FINDINGS

Given that the shelter along City Center Dr. has a restroom attached to it. Increasing the cost of renting the shelter is prudent. For example, Greenville Parks and Recreation on average charges \$100 for a half day rental of shelters with bathrooms attached to it. Greenville Parks and Recreation also states that any facility permit does not give exclusive use of the entire park/facility.

RECOMMENDATION

Mauldin Recreation recommends a rental fee of \$100 for the rental of the shelter along City Center Dr., which is attached to a restroom. The shelter has two playground areas within six feet. Reserving the City Center Shelter does not give the renter(s) exclusive rights to the playground during their rental period.

SUBJECT: Designating the Shelter & Playground along City Center Dr. as a City Park

REQUEST

Council is requested to designate the Shelter & Playground along City Center Dr. as a City Park.

HISTORY/BACKGROUND

The City has four parks: City Park, Springfield Park, Sunset Park, and Pineforest Park. The construction of a shelter and playground along City Center Dr. was recently completed and is now being used by the public. However, City Council has not designated the shelter and playground as a park.

ANALYSIS / STAFF FINDINGS

Designating the Shelter & Playground as a park would provide clarity as it relates to the area operations. If it is designated as park the City's ordinances related to the hours of operations, rules, etc. for the City parks would apply.

FINANCIAL IMPACT

None.

RECOMMENDATION

Staff recommends designated the Shelter & Playground along City Center Dr. as a City park. Attached is a rendering of the proposed park area, should Council proceed with the park designation.

Sec. 30-1. - Dogs permitted in public parks.

Dogs shall be permitted during park hours of operation under specific conditions spelled out in "Dogs in Park Rules."

Violation and penalty. Any person who brings dogs to parks and recreation facilities and does not follow the stated park rules is in violation of this chapter and subject to its remedies and penalties.

Any person in violation of this chapter is guilty of a misdemeanor and, upon conviction, must be fined between \$10.00 and \$25.00. (S.C. Code 1976, §§ 44-95-10 et seq. (1996)).

Sec. 30-2. - Interference with permittees.

No person in a park shall disturb or interfere unreasonably with any person or party occupying any area or participating in any activity under the authority of a permit.

No person in a park shall have brought alcoholic beverages into such park, nor shall any person drink alcoholic beverages at any time in the park.
