3. Reading and Approval of Minutes
 - a. Finance Committee Meeting: November 1, 2021

Motion: Councilwoman Kuzniar made a motion to approve the minutes with Councilwoman King seconding.

Mr. Madden said the budget looks good.

Mr. Putnam said the City had a good insurance year. Not a great year like 2020, but we will put \$170,000-190,000 back into the insurance reserves. All of our insurance providers will stay the same for 2022. Using Southern Scripts for our prescription services, we will be able to put about \$30,000 back into the reserves.

Councilwoman King asked if there were any employee increases in insurance cost. Mr. Putnam said there was a 5% increase in gap insurance cost.

Chairman Reynolds asked about a wellness program. Mr. Putnam said Proactive has been helping us with our claims and wellness because some of our employees don't have a family doctor. We have some employees that are now going to the doctor on a regular basis.

Chairman Reynolds asked about changing the timing of insurance enrollment to coincide with our budgeting process. Mr. Madden said if that change was made, then we will be projecting instead of having a more accurate picture. It would be by Council's preference. If the Council does decide to change the renewal timing, the City would have to get bids for six-month

coverage and may experience rate increases through that process.
