b. An ordinance to rezone property consisting of approximately 5.6 acres located at 513 North Main Street (Tax Map Parcel: M008.01-01-001.00) and providing an effective date

**Motion:** Chairwoman Kuzniar made a motion to accept this ordinance on second reading with Councilman Matney seconding.

**Vote:** The vote was unanimous (7-0).

Ordinances - 1st Reading

a. An ordinance to rezone property consisting of approximately 0.5 acres located at 301 E. Butler Road (Tax Map Parcel: M004.02-01-010.01) and providing an effective date

**Motion:** Chairwoman Kuzniar made a motion to accept this ordinance on first reading with Councilman Black seconding.

**Vote:** The vote was unanimous (7-0).

b. An amendment to section 3:12.3.8 of the Mauldin Zoning Ordinance to provide a description of moving trucks and trailers

**Motion:** Chairwoman Kuzniar made a motion to accept this ordinance on first reading with Councilwoman King seconding.

Councilman Black reminded everyone this ordinance passed on April 19, 2021 and what is being considered tonight is just for clarification.

# c. Sewer Rehabilitation Program

**Motion:** Chairman Kraeling made a motion to approve amendments 3 and 4 to the agreement dated March 17, 2015 between the City of Mauldin and Frazier Engineering, P.A. with Councilman Matney seconding.

**Vote:** The vote was unanimous (7-0).

#### d. Senior Center Elevator Contract

**Motion:** Chairman Kraeling made a motion to approve a contract with Schindler Custom for the maintenance of the elevator at the Senior Center. Councilwoman King seconded the motion.

Vote: The vote was unanimous (7-0).

# e. GLDTC Participation Agreement Projects #588.01

**Motion:** Chairman Kraeling made a motion to approve the Greenville Legislative Delegation Transportation Committee (GLDTC) Participation Agreement Project #588.01 and to add an additional \$180,000 to its participation amount in the MMRP. The additional \$180,000 is a portion revenue lost due to the COVID-19 pandemic that was provided for via the 1st tranche of the American Recovery Plan Act funds. Councilwoman King seconded the motion.

**Vote:** The vote was unanimous (7-0).

## f. Trail Feasibility Study

**Motion:** Chairman Kraeling made a motion to approve an agreement with Davis & Floyd to conduct a feasibility study for a 2,400' multi-use trail along Gilder Creek. Councilman Matney seconded the motion.

Vote: The vote was unanimous (7-0).

## g. City Administrator's Contract

**Motion:** Councilman Matney made a motion to consider this item informally. Councilwoman King seconded the motion.

**Vote:** The vote was unanimous (7-0).

**Motion:** Councilman Reynolds made a motion to raise the Administrator's salary to \$130,000, extend his contract for three years, and to give him a performance bonus in the amount of \$5,000 for his leadership during the Covid crisis. Councilwoman King seconded the motion.

**Vote:** The vote was unanimous (7-0).
