2. Public Comment- None
3. Reading and Approval of Minutes
 - a. Public Safety Committee Meeting: May 2, 2022

Motion: Councilman Allgood made a motion to accept the minutes with Councilman Kraeling seconding.

Vote: The vote was unanimous (3-0).

4. Reports or Communications from City Officers
 - a. Fire Chief Brian McHone
 - i. Budget Review

Chief McHone reported the department is under budget. Training on the new tower truck will be Tuesday, Wednesday, and Thursday of this week. The stormwater drainage for the new fire station is being installed now.

- b. Judge Angela Martin

Judge Martin was not present but did send an email to committee saying she is 9% under budget and should still be under budget by the end of the year.

- c. Police Chief George Miller
 - i. Budget Review

Lt. Hodrea was present for Chief Miller in his absence. He reported the department is where it needs to be regarding the budget.

6. New Business
 - a. Insurance and Bonds for Fire Station

The contract and the guaranteed maximum price have already been approved. Now council will need to approve Exhibit B of the contract, insurance and bonds.

b. Digital Government Services Customer Agreement

Approval of this agreement will allow the Judicial Department to continue using the Enterprise Payment Services application to accept electronic payments from its customers.

c. Records Retention Schedule

The Chief of Police is asking for authorization to sign the retention schedule regarding records expungements.

8. Committee Concerns- Chairwoman King expressed concerns about making sure businesses and residents are aware of our codes. She would like the police department to be proactive in our community. We have businesses and residents in the City that are not following our codes. As the police department sees violations, they can be reported to the Codes Enforcement Officer.

Councilman Kraeling said he had talked to Chief Miller regarding higher penalties for things such as littering and other codes issues.
