4. Public Comment

David Graffius: Good evening. My name is David Graffius and I am with Gray Engineering. My address is 132 Pilgrim Road in Greenville. I would like to talk about annexation and establishment of Tanner Road Planned Development ordinances on the agenda tonight. Based on discussion on first reading regarding the development and application at last month's council, there were questions from Council and the Planning Commission on mitigations that may be required by SCDOT on the project. Our team has heard the comments and subsequently have had discussions with SCDOT. However, we do not have a complete picture of what SCDOT will require or the cost of the same. As a result, we would like to respectfully request additional time to continue discussions with SCDOT, which we anticipate will take no longer than 30 days. This additional time will allow our team to meet the requests from Council and bring the most comprehensive answers possible. To that end, we kindly request the second reading be deferred to the November 21, 2022 meeting.

9. Public Comment

a. Marcos Lisak: I live at 108 Belgian Blue Way in Fountain Inn. I reside with my wife and four children in Fountain Inn and am asking for an amendment to open a coin shop or a gold and silver shop here in Mauldin. There is a 30,000 square foot minimum or larger requirement that I do not meet. Currently we are a family business and online only, but are looking for a local presence. We deal in high quality numismatics, new and old coins. We are not a pawn shop. No loans. I would be partnered up, if approved, with Mr. McChesney where old Mauldin Deli used to be. I would sub-lease from him. It would be a small square footage- 600 to 700 square feet.

Mr. McChesney: I am a small businessman in Mauldin. We are concerned about our image and have investigated this guy pretty well. If you are concerned about whether this would be good for Mauldin, don't be. He will be right beside us. And on the zoning side, for certain purposes doesn't exactly fit, I think this would be positive.

10. **Council Concerns**- Councilman Reynolds asked about the process to withdraw an ordinance from the Council agenda. Is there a verification that the person who is withdrawing the property is actually the person who is authority to do so? Mr. Dyrhaug said he knows Mr. Graffius represents the property, and he has worked with him throughout the process. If there were concerns, they would be brought to Council's attention. Mr. Dyrhaug has encouraged applicants to come forward to Council so that the public is aware of what is happening in the process and ensure Council makes the final decision.
