## **REQUEST**

---

The Recreation department is requesting a discussion on what to name the new bridge over 385 leading to Bridgeway Station.

## **HISTORY/BACKGROUND**

---

The new pedestrian bridge is set with the intention of connecting BridgeWay Station to the Swamp Rabbit trail. The bridge will be a connector for the residents and non-residents to enjoy the many amenities the new BridgeWay Station will have to offer.
