High School Musical Jr. starts Friday. The first show is 50% sold out.

The Mauldin Blues and Jazz Festival is April 20th. 12 food vendors and two beer trucks will be available.

The Summer Camp has started registrations.

The mural will be installed by the end of April.

Engineered drawings on the steps have been released. The step design will stay consistent with the present look.

Councilman Kraeling asked if anything was going on with the Club Epic building. Mr. Duncan said they are still working with the insurance company. The City has received no permit requests.
